



## **WARREN COUNTY TECHNICAL SCHOOL PARENT COMPACT**

Warren County Technical School and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) (participating children), agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

### **Warren County Technical School will:**

*Parents will receive report cards at the end of each marking period. Parents will receive informal periodic updates on student progress throughout the school year via phone, letter, Genesis Portal, or email at teacher discretion.*

**4. Provide parents reasonable access to staff:**

*Staff will be available for parents via phone and email daily. Should a meeting be requested, an appointment should be made at least 24 hours ahead of time.*

**5. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities, as follows:**

*Parents are welcome to volunteer at all school-wide functions, through PTA involvement, and at specific*

*activities throughout the year. Parents will be notified of other opportunities as they arise.*
